Article 1 The Regulations of the University are established in accordance with Article 20 of the University Act and the University's regulations on the establishment of the Faculty Evaluation Committee.

Article 2 The Faculty Evaluation Committee of the College of Business (hereinafter referred to as the Committee) is responsible for reviewing the following matters concerning full-time and part-time faculty within the College of Business:

1. Appointments, duration of appointments, suspensions, dismissals, non-renewals, and determinations of reasons for termination.
 2. Matters related to faculty promotions and applications for re-evaluation.
 3. Faculty evaluation matters.
 4. In cases where decisions regarding suspension, dismissal, or non-renewal made by a department- or institute-level faculty evaluation committee are clearly inconsistent with current regulations and substantiated by clear evidence, the Committee may review and modify these decisions in accordance with regulations.
 5. Other matters requiring review by the Committee as mandated by laws and regulations.
- After the Committee's review, cases will be forwarded to the University Faculty Review

Committee for further review.

- Article 3 The Committee consists of seven to nine professors. The Dean serves as an ex-officio member and acts as the convener and chairperson of the Committee meeting. The remaining six to eight members are elected by the College Affairs Meeting and serve a one-year term.
- Article 4 All members of the Committee are required to attend meetings in person. A quorum of at least two-thirds of the members must be present for a meeting to proceed. A resolution requires approval from more than two-thirds of the members in attendance. Voting is conducted anonymously. If the ex-officio member is absent, a substitute with equivalent faculty qualifications shall take their place.
1. Any member who is absent from the Committee meetings without valid reason three times will lose their membership status.
 2. If a vacancy arises, it shall be filled in accordance with the original provisions of the Regulations.
 3. Members who are directly involved in a matter under review must recuse themselves. The evaluation of an applicant's publications or works should respect professional assessments, and it is not suitable to make resolutions on such academic competencies through anonymous voting.
- Article 5 As a general principle, the Committee should meet at least once each semester. Extraordinary meetings may be convened as necessary.
- Article 6 If necessary, the Committee may, by resolution, invite relevant personnel to attend meetings to provide explanations.
- Article 7 Matters concerning faculty appointments, promotion evaluations, applications for re-evaluation of promotions, handling of plagiarism in faculty publications, and other related issues shall be managed in accordance with relevant regulations.
- Article 8 The Regulations shall be implemented upon approval by the College Affairs Meeting and submission to the University's Faculty Review Committee for approval and documentation.
